

## Techniques for Finding Electronic Articles or Journals

Check for individual journal subscriptions first

1. Check the **EuclidPLUS** (<http://catalog.case.edu/>) online catalog by doing a title search for the journal name
2. Check the **Case Electronic Journals** (<http://atoz.ebsco.com/Search.asp?id=1408&sid=208848078>) list for a combined list of individual subscriptions held on campus and also found in the OhioLINK Electronic Journal Center.
3. Check the **Haworth Press Journals** (<http://www.haworthpressinc.com/store/E-Text/ViewLibraryEText.asp>) list for Social Work journals that might not have been included on the Case Electronic Journals yet.

Check for journals that are part of Full Text Electronic Databases. (all resources listed in this section can be accessed from the Research Databases [<http://www.case.edu/cgi-bin/database> ]).

4. Check the **OhioLINK Electronic Journal Finder** (<http://www.ohiolink.edu/resources/ejournals.php>)  
This site searches through the databases Academic Search Premier, Business Source Premier, Humanities Abstract, Education Abstracts, Lexis Nexis, and the OhioLINK EJC.

Type the name of the journal in the search box. If it is included in one of the sources listed above, Click on the link provided for the name of the database. This will take you to a list of articles found in that database for the journal you searched. Simply add the author's name or a keyword from the article title in the search boxes to limit the results.

5. Ebsco Electronic Journal Service (exclusive to Case only). Many of the journals here will be repeats of what you will find in the OhioLINK Electronic Journal Finder. However, there are enough differences between these two that it is worth searching. This source is good for obscure and more popular journals.
6. Expanded Academic Index-(exclusive to Case only). Click on "Journal Search" on the left hand side to see if the journal you seek is available here. Lots of journals on Child psychiatry and psychology here!
7. PsycArticles- (exclusive to Case only). This collection consists entirely of journals that are published by the American Psychological Association from 1988 to present. All are full text.
8. Jstor- (exclusive to Case only). This is a collection of older, limited materials. Most cover from the start of a journal run to fairly current. (example 1947-1993 or 1888-1997). It has a limited number of journals in its collection.
9. Project Muse- (exclusive to Case only). A collection of 200 scholarly journals in the humanities, social sciences and mathematics.
